Student/Parent Agreement & Pledge for iPad Use

- I will not loan my iPad out to other individuals, will not leave my iPad unattended and will know where my iPad is at all times.
- I will bring my iPad to school each day, fully charged.
- I will keep food and beverages away from my iPad since they may cause damage to the device.
- I will not disassemble any part of the iPad or attempt any repairs.
- I will protect my iPad by keeping it in the case provided at all times.
- I will use my iPad in ways that are appropriate and meet all district expectations.
- I will not place decorations (such as stickers, markers, paint, etc.) on the iPad or accessories. I will not deface the serial number or asset tag barcode sticker.
- I understand that the iPad is subject to inspection at any time without notice and remains the property of Hastings Public Schools.
- I will follow the policies and procedures outlined in the iPad User Agreement and District Acceptable Use Policy for Internet, Network, Electronic Equipment and Communication.
- If the iPad is damaged, lost or stolen, I am responsible to pay for the damage or replacement of the device. Repeated damages, loss, or theft may result in the forfeiture of use of an iPad.
- I agree to report any damage, loss or theft of the iPad and/or its protective case to school personnel or law enforcement (in the case of theft) within 24 hours or as soon as possible.
- I agree to return my iPad promptly at the end of the school year or upon my withdrawal from Hastings Public Schools. I understand that if I fail to return the iPad and accessories (iPad case, Apple cord, and charging brick) at the end of the school year or upon termination of enrollment in Hastings Public Schools, I may be billed for the cost to replace items not returned. Failure to comply with this requirement may result in a theft report being filed with the police department.

Cost for Replacement and/or Repair: *In the event of partial or complete damage to a device, or the device becomes lost, repair or replacement cost is the responsibility of the student. These are only approximate costs. Total cost is dependent on the severity of the damage.*

FOR THE STUDENT:
